

DETAILS

Purpose

The purpose of this book is to highlight the work and the philosophy of futures work in Africa, focussing on the unique context, culture, history and experiences of different African countries, and to raise awareness of futures thinking emanating from Africa and for the benefit of Africa.

Authors / Contributors

A number of authors will contribute to this book and these names will appear on the jacket and title page of the book.

The contributors have been selected by myself from futurists whom I have connected with in Africa.

Agreement

We enter into an agreement for you as an author to write and contribute a chapter of approximately 3,000 to 5,000 words towards a book with the working title of "Africa's Futures".

The following sets forth our mutual understanding of the allocation of publishing rights of this book and the royalties and other considerations to which each author may be entitled.

Roles

This agreement does not constitute a permanent partnership between us and exists for the purpose of compiling this edition of Africa's Futures.

Credit and Responsibilities

The copyright of the book will reside with the publisher, (Charlotte Kemp) with each contributor having the right to republish their chapter no earlier than nine months after the initial publication of the book.

Each author may reference their co-authors' contributions with full attribution.

Expenses

Any expenses incurred in the writing and/or researching of any individual chapter of the book shall be for that contributor's own account and may not be reimbursed from the sale of the book or from any other contributor or the publisher.

There is no cost or buy-in price for the author to contribute to this book as there would be for a vanity publishing project.

Publishing

The book will be published as an ebook under the existing Amazon account of Charlotte Kemp and will be connected to any of the contributing authors' Amazon accounts.

Contributing authors may republish the book online, only nine months after the initial publication date by the publisher.

Royalties and related Income

Royalties from book sales on Amazon and other online platforms shall be for the account of the publisher.

A print ready version of the book will be provided to each contributing author who is then free to print, price and sell their copies of the book at their own events.

Liabilities and Indemnities

Each party warrants that any material written or provided in connection with this book is not in any way a violation of a copyright, or common law, or right of privacy, and that it contains nothing of a libellous, obscene, or illegal character.

Each party agrees to indemnify and hold the other party harmless against any loss or damage arising out of a breach of any warranties or any other incorrectness in any of the representations.

Division of Labour

Compilation, editing, publishing, marketing and promotion of the book and the authors will be done by Charlotte Kemp.

Each contributing author is required to contribute their chapter as well as engage in a minimum of one live online session with the rest of the authors.

List of Authors

A list of contributing authors will be made available to all contributing authors on acceptance of this agreement.

Contingencies

In the event that any of the authors is unable or unwilling to continue or complete work on "Africa's Futures" to the satisfaction of the other contributors or the publishers, the remaining contributors may complete work on the book, without the assistance or agreement of the withdrawing party.

Should the contribution of any author not be approved by the balance of the contributors, then there will be an opportunity fo the relevant chapter to be revised or re-edited and then resubmitted to the balance of the authors for approval. If there is failure to agree on the second contribution, then the relevant chapter will be withdrawn from the book.

If we are unable to reach an agreement we will agree to submit these negotiations to binding arbitration. We agree that none of us will ever take any action that will harm the message of the book.

Succession of intellectual property

The terms and conditions of this agreement shall be binding and continue to the benefit of the executors, administrators and successors of each of us.

Time Table

Content for the book should be completed by all parties according to the following timetable.

- 30 January 2023 Initial draft of chapter concept and initial collaboration sessions with other authors
- 24 February 2023 Chapter submission for editing and review
- 3 March 2023 Chapters available to all authors for review and acceptance
- 17 March 2023 All reviews completed and book will be made ready fo publishing
- 24 March 2023 Book available for print and available on Amazon.

Meetings

To foster collaboration, understanding, networking and the enhancement of our work and this book, a series of meetings have been arranged for us to share our concepts and to discuss Africa's futures as seen from our perspectives.

It is required that each author attend at a minimum, one of these sessions. There will be a series of dates in January and February.
